- WP3 Outcome
  - To develop an inventory of existing CPD programmes and providers, and agree on core components.
- Deliverable 3.2: Questionnaire
- Deliverable 3.3: Database of CPD





## **Questionnaire Development**

- Initial draft circulated and debated at SIGs at ADEE 09 and ADEE 10
- Multiple redrafting by Cardiff Team
- Comments from partners
- Piloted by a small group, mid-Nov (partner institutions)
- Further revisions





#### **Distribution Process**

- End of November preliminary email sent to all in contact list which verified email addresses, introduced the project and gave respondents a chance to nominate others more suitable to respond if necessary.
- Survey sent on 2nd December to 706 contacts across Europe and beyond, with a deadline of 19th December 2010.
- Reminder email sent to non-respondents on 20th December 2010. Deadline extended to 17th January 2011. Additional others contacted where we had no response from particular countries.





#### Questionnaire recipients

- Dental associations of the EU
- Dental schools through ADEE network
- Attendees expressing an interest at SIG ADEE09 and ADEE10 (all attendees)
- Known links across the EU





#### Results

- 172 responses by March 2011
- Note: responses are presented appropriately either by 'single country' (n=29) or overall (n=172 max; 138 EU). Modal responses formed the basis of the single-country data.





## Official, regulated system for CPD? (Q2)

Country Responses	n (%)
Yes, compulsory and regulated system for all dentists	13 (43%)
Yes, optional regulated system	8 (27%)
No but recommended amounts of CPD	3 (10%)
No official system	5 (17%)
TOTAL	29

- All have a national regulatory body for dentists.
- All indicated graduate dentists are required to be recognised by this body before they can practice.
- 53% require annual registration.

- The dentists most commonly funds CPD
- The Dentist 25
- Other 18 (mainly 'funded by employer')
- University Dental School 15





Personal views (Q16)

I think that CPD should be obligatory for all dentists 129 (76%)

All countries should have an official, national, accredited CPD system 122 (72%)

More CPD should be available electronically (e-learning) 86 (51%)

- Majority think CPD should be obligatory and that all countries should have an official system
- Only about half think more CPD should be available electronically
